Capitol Hill motioned to approve the \$2 increase. Mt. Baker seconded. During discussion, Beacon Hill suggested cost-cutting, particularly unused fields. Lake City noted that every dollar added is a dollar not covered by volunteers. The motion carried with one opposed and one abstention.
