# **OLD BUSINESS**

- (David Funke) Bylaws update: Recently presented new draft to the executive board which took into consideration the changes that had been presented to me.
  - o Comments/additional changes?
    - (Shannon Palmer) Should we include language that defaults to board or another member of board to take responsibility for certain things when a position isn't filled (example: Secretary)? In general, if there is a critical role missing, what happens?

- (Shannon Palmer) 4.5.1 Reword sentence about how notices are served
- (Shannon Palmer) 5.2.1 Can we review length of time board is given to re view candidates?
  - (Kevin Long) 2 weeks sounds like a pretty tight timeline
  - (David Funke) Make it 30 days minimum that candidates need to submit statement?
- (Shannon Palmer) 5.7 for treasurer, legacy language, can we change this? (Shannon Palmer) 7.4 DEI, submitted new proposed text
- o (Greg Parker) How will the inter-league play work with the disciplinary committee as these different leagues will have different committees?
- O (Greg Parker) Suggestion on the bylaws update process, final document ready for the Annual meeting in February? We could benefit from taking what we've done thus far, editing out confusing and archaic language, and also thinking about having a tiered structure that covers how we adopt policy. Let's get a group of 3-4 people to sit down and put together a good, substantive draft for February. Plan for functional doc by February, send it to legal in March, AGM in April.
- (Greg Parker) Complaints about game day behavior, grievances process and repercussions: 
  Our How do our individual clubs deal with trying to manage sideline behavior? 
  Put together a 'best practices' document to find a common approach to managing this
  - Review what authority SYSA has

# **NEW BUSINESS**

- (Corey McNamee) Compliance process for select player rule:
  - o SYSA changed the rule a few years ago to include SU players because Celtic and Em erald City were playing and we didn't want to exclude SU
    - We should move forward with changing registration to include a mandatory field ask ing about what teams players are playing for, outside of SYSA. Club, level of play and possibly the league they play in, are among potential required pieces of information.
      - Both Emerald City and Celtic are in agreeance to help. They will tell their fam ilies to answer the select soccer questions during recreational registration hon estly.
        - This change will not happen for spring, but can have in place for fall
  - (Paige Blomso) A lot of our families just don't understand the rule, and we are relying on volunteer coaches to get this information to them. We need to do a better job at the association level in letting our families know the rules. We need to start at the grass roots level.
