- Spring soccer: coaches meeting Mar 22; planning continues
- State of Play Meetings: King County initiative focused on diversity and giving groups with smaller numbers more opportunities to play; numerous organizations involved; still trying to formalize, create a board
- Sounders FC meeting: partnership growing, many ideas and new initiatives
- Submissions needed: Coach of the Year (Rec & Competitive), Volunteer of Year, Admin of the Year
- Budget: thanks to John Clark and Susan Martin for their work on this
- Interplay request: Eastside YSA inquiring about Fall 2020 participation with SYSA teams for high school-age teams

## 2020-21 Budget presentation

## Beacon Hill low income support request

Magnolia moved and Capitol seconded to approve the \$4000 request. Topics for discussion included fee collection procedures; registration practices; aid application process; general questions about guardrails; whether club can become self-sustaining. With discussion ended, motion was approved with eight votes in favor, four against.

It was motioned to require any club seeking SYSA financial assistance for the Fall 2020 season to meet with the Executive Director, VP of Operations and SYSA registrar for a review of business and registration practices prior to opening of registration. Passed unanimously.
