Old Business

Age Group cut off discussion – Dave Funke

Proposed changes to the SYSA Administrative Regulations (deleted text in strikethrough, additions underlined):

- 1.3 Players are required to play in a division of their own age group. They will not be allowed to play in a division of players younger than themselves except as provided below. They may play in a division of players older than themselves with the approval of their club. Use of an overage player shall result in forfeiture of all games in which that player participated.
 - 1.3.1 In the event a player has a medical or developmental reason to play on a team in a division of younger players, such player may make an application for an exception to this Rule. Such application must be made to the Medical-Play-Down Committee as established by the SYSA Board of Commissioners, and the determination of the committee may be appealable to the Board of Commissioners. Such application shall be made using forms provided by SYSA, and accompanied by statements from a medical provider that meet the guidelines and standards provided on those forms. Such exception will be granted only for good cause. The application must be submitted to the committee at least 14 days prior to the first league game in which the player participates, and will be granted for the SYSA seasonal year.

- 1.3.2 The Medical-Play-Down Committee shall consist of the SYSA Executive Director, the Vice President of Operations, and the SYSA Registrar.
- 1.3.3 School Grade Level Exemption. Recognizing that recreational soccer is supposed to be fun, and that the specified age cutoff dates may create circumstances where a player may be excluded from playing with their school peer group, the Play-Down Committee may grant exemptions for players with June and July birthdates to play down from their specified age group in order to play with school grade peers. The exemptions will be evaluated individually and may be denied for cause. Proof of grade level (copy of report card or other school documentation) will be required. Application for a grade level exemption shall be made using forms provided by SYSA and accompanied by the proof of grade level documentation. The application must be submitted to the committee at least 14 days prior to the first league game in which the player participates, and will be granted for the SYSA seasonal year. The exemption must be renewed each year. The exemption will apply to both fall and spring soccer.
- 3.3.9 The VP of Operations WILL NOT accept team registration from any club under the following conditions:
 - 3.3.9.1 When registration format other than those designated by the VP of Operations are used.
 - 3.3.9.2 When a team attempts to register after WSYSA and SYSA published deadlines.
 - 3.3.9.3 When a team includes an overage player, unless approved by the Play Down Committee.

Also separately proposing a team play down rule:

1.3.4 Teams U14 and older may petition to play down if the team is predominately players of the younger age group and no more than three of the players on the roster would be playing down. The club registrar shall request the exemption by the time of the Alignment Meeting or a date set by the SYSA Registrar. Play Down Committee shall be informed of the exemption request and shall grant the exemption unless the committee determines the playdown would create an unfair competitive situation.

Hillwood moved to adopt, Beacon Hill seconded; carried unanimously.

United Soccer Coaches Agreement – David Griffiths

Griffiths presented an outline of the proposed affiliation and what the program would offer SYSA coaches. There was some discussion about the degree to which the resources would be used. McGilvra moved to discontinue the arrangement with Positive Coaching Alliance and replace it with United Soccer Coaches; seconded by Beacon Hill. Passed unanimously.
