 - Asked to Review Select Player rule
- Treasurer (Dave Funke reporting for)
 - Reviewed P&L for the year
 - \$90K in black (June 1 to May 31)
 - Increase in income from Spring soccer
 - \$40K lower than budgeted for field billing
 - Misc. expenses not spent
 - Balance sheet \$40K in the black
- VP of Rec Development (Kris Espinoza) Nothing to report
- VP of Diversity & Inclusion (Shannon Palmer Not Present
 - No report
 - Did not meet
- VP of Marketing & Communication (Calen Holbrooks)
 - Coaches Community Proposal
 - Coaches Community a way to share content, communication, & best practices
 - Utilize SLACK app a place to customize groups & spaces
 - Feedback from Clubs on SLACK app
 - Hillwood (Silas Lindenstein) ignored slack when used on a different board, but likes the idea
 - LVR (John Blackham) likes the idea as a way for peers to address coaches behavior
 - Disciplinary Chair (Chris Tuttle) way to vent & get peer input

- Calen stated there was a way for Slack to auto-govern based on key words
- Lake City (Mark Baker) who will administer?
 - Jenn Ireland stated that could be set up and monitored by 1 person
- Next Steps
 - Submit a proposal plan
 - Invite coaches to pilot late July/early August w/association coaches
 250 free users; non-profit rates for more than that
 - Hillwood Volunteered to pilot
- Disciplinary Chair (Chris Tuttle)
 - Issue with Capital Hill email not receiving messages
 - Please ensure reps of all disciplinary committee members are checking emails and responding (check in every week or two)
 - Will send out lists of reps for clubs to verify
- SSFA (Larry Metz)
 - Asked Duncan Munro from Seattle Refs Committee (SRC) to speak
 - Look at ways to strengthen partnership
 - Assist in recruiting and retaining referees
 - New Referee certification clinics with local clubs (Woodland, Magnolia, & Beacon Hill clinics in 2022)
 - Need to work on ref development & retention
 - 85% of new refs complete a game within 1 week of course completion
 - Spring program were all new refs
 - Support from Seattle United
 - Please Reach out to Duncan if you would like to host a clinic
 - Areas for improvement
 - Add more adults (70% of new refs are 13)
 - Raise understanding of the game (should this be a requirement for coaching?) & rule changes

- More fields got lights for this fall
- Dahl Field issues (Lake City) please disseminate contact info to clubs on how to get lights tuned on
- Executive Director (David Griffiths)
 - WYS to push standardized rules across competition
 - Ease for refs
 - Reduce level of disinformation & animosity on confusion
 - U17-U19 club is moving on!
 - 100% interest in program from surveys
 - Cost \$55 or less
 - Spring soccer -2 weeks left
 - Easier this year than others (fewer issues & less complaints)
 - Successful ref program w/mentors
 - AGM WYS (May 20th)
 - US Youth universities great resource for coaches
 - \$5 for profile

CLUB REPORTS

- Seattle United (Kevin Long)
 - Tryouts completed over 3 weeks
 - 2097 players registered
 - Annual coaches summit held
 - Kevin Long stepping down at end of summer
 - Kyle Rodheaver to cover until a permanent decision made
- Woodland
 - Registration is open
- Queen Anne
 - Registration is open

- Question on select player rule does SU or other clubs give lists on who were playing on their teams, but are not anymore
 - To check with Kevin, Anne, or Paige
- Magnolia
 - Registration is open (at 45% of target)
- Ballard
 - Registration is open
 - Need to fill 1-2 board positions
- Hillwood
 - Registration is open lots of micro players registered
- Shorelake
 - Registration is open (80% of last year)
- Lake City
 - Registration is open
- LVR
 - Registration is open; nervous about impact of Celtic and Select Player Rule
 - U6 Program running (3rd year)
- Beacon Hill no report
- Mc Gilvra Registration is open (numbers close to last year)
- Capital Hill
 - Email is not functioning
 - New email created
 - Registration is open but are down quite a bit
- Mt Baker
 - Registration is open (up 60% over last year)
 - Fields person leaving in August trying to recruit support, but may need help

SELECT PLAYER RULE

- Problems
 - Who are select players?
 - Rule Changes Registrars to manage
 - Potential of teams breaking up
 - Considerations for older age groups to prevent drop outs due to low numbers
 - Purpose of rec & desire to honor that spirit
- Ideas
 - Diagram on website to illustrate the rule
 - List nomenclature of select teams and what level they fall in
 - Change some sentences in rule (i.e. if you have 3 select players team will play up a year)
- What can we do?
 - David G. registrars, exec director, competition committee to make decisions on how many players a team can have?
 - Daivd G. decisions made to avoid slaughtering of teams
 - Stephanie age group rule difference? Develop a process for teams to go to the board for exceptions?
 - Mark B Problem in alignment divisions are not true to actual level
 - Anne registrars can move teams based on record

- Dave F Goal is to keep teams playing & to keep play competitive
- W/out allowing some select players, you could lose them to USSF programs (i.e. Celtic)
- Anne two most common things heard
 - What defines the levels between select & rec?
 - What Celtic teams are considered Select?
 - Managing select players can you have all your select players on field at once? (managing game to keep spirit of rec.)
- Shelly volunteered to reach out to Celtic for advice on what levels they consider Select.
- Mitch woodland supports the rule
- John concerned that select players could displace rec players or reduce their playing time
- Dave G are we propping up rec teams or supporting select teams need to look at club philosophy on forming teams.
